Preference Shareholder Rebates

1. MainPower's Preference Shareholders (also known to as Rebate Shareholders or Qualifying Customers) continue to receive Rebates.

The amount of Rebate distributed to these customers and the manner in which it is distributed is subject to regular review by the Board of MainPower. Rebates are only made available at the discretion of the Board.

2. The Board has agreed that Qualifying Customer Rebates should remain unchanged from 1 March 2012 at 1.905 cents per Unit, i.e. Rebates will continue at 1 April 2008 Levels

Notes

- Kaiapoi ICPs refer to those customers who were previously connected to the Kaiapoi Electricity Network.
- A Fixed Line Charge waiver may apply for certain Codes in special circumstances. i.e. when approved by MainPower in writing.
- An approved Fixed Line Charge will apply for a minimum period of 12 months.

Residential Charges

- Storage water heating must be subject to control in order to qualify for Residential Controlled and/or Night Special Supply.
MainPower reserves the right to waive this requirement under special circumstances.
- Night Special is available for approved fixed wired storage water heating, storage space heating and other approved systems.
Supply of Night Special is limited to a maximum of 8 hours between 9.30pm and 7.30 am. Storage water heating is subject to control.
The Fixed Charge for Residential Controlled Supply coupled with Night Special is 30.00 cents per day excluding GST and after Prompt Payment Discount has been applied, (Low User Option 15.00 cents per day).

Charges for Other Supply

- The above Line Service rates for "Other Supply" customers assume that storage water heating and water storage for pumping purposes is controllable by MainPower.
MainPower reserves the right to waive this requirement under special circumstances.
MainPower also reserves the right to charge a higher fixed charge where a waiver is not approved and the customer requests Uncontrolled Supply.
MainPower also reserves the right to charge a higher fixed charge where Power Factor Correction requirements are not maintained.
- Large user customers, i.e. customers consuming over 500,000 units per annum, may qualify for a volume discount.
The level of discount is subject to negotiation between MainPower and each individual customer.
MainPower will take into account a customers load characteristics and other relevant circumstances.
