# Rebates

MainPower's Preference Shareholders (also known as Rebate Shareholders or Qualifying Customers) continue to receive Rebates. The amount of Rebate received by Preference Shareholders and the manner in which it is paid, is subject to regular review by the Board. Rebates are only made available at the discretion of the Board of MainPower.

Rebates are paid monthly through the Electricity Retailers. Some Electricity Retailers choose not to show the rebate as a separate line on the invoice.

# **Charges for Other Supply**

- 1. The above Network Charge rates for "Other Supply" customers assume that storage water heating and water storage for pumping purposes is controllable by MainPower. MainPower reserves the right to waive this requirement under special circumstances. MainPower also reserves the right to charge a higher fixed charge where a waiver is not approved and the customer requests an Uncontrolled Supply. MainPower also reserves the right to charge a higher fixed charge where Power Factor Correction requirements are not maintained.
- 2. Large user customers, i.e. customers consuming over 500,000 units per annum, may qualify for a volume discount.
