Notes

- All Prices are exclusive of GST.
- An approved Fixed Network Charge will apply for a minimum period of 12 months.
- Large user pricing is individual, the schedule rates are an average and therefore are indicative only.
- The distributed generation pricing option applies to all distributed generation regardless of whether it is on a residential or other supply price category. It is zero rated for the 2020/21 year.
- A distributed generation supply MPDISTGEN is assigned to ICPs which are export-only without importing electricity from the MainPower network.

Rebates

- MainPower's Preference Shareholders (also known to as Rebate Shareholders or Qualifying Customers) receive Rebates.
- Customers connected to the former Kaiapoi Electricity network are not Preference Shareholders and instead receive a discount equal to the rebate paid to Preference Shareholders.
- Rebates/Discounts are paid at the discretion of the Board of MainPower. The amount of Rebate/Discounts distributed and the manner in which they are distributed is subject to annual review by the Board of MainPower.

Residential Charges

- Storage water heating must be subject to control in order to qualify for All Inclusive Residential and/or Night Only Supply. Supply of Night Only is limited to a maximum of 8 hours between 9:30 p.m. and 7:30 a.m. Storage water heating is subject to control.
- Night Only is available for approved fixed wired storage water heating, storage space heating and other approved systems. Supply of Night Only is limited to a maximum of 8 hours between 9.30pm and 7.30 am. Storage water heating is subject to control.

Charges for Other Supply

- The above Network Charge rates for "Other Supply" customers assume that storage water heating and water storage for pumping purposes are controllable by MainPower. MainPower reserves the right to waive this requirement under special circumstances. MainPower also reserves the right to charge a higher fixed charge where a waiver is not approved and the customer requests an Uncontrolled Supply. MainPower also reserves the right to charge a higher fixed charge where Power Factor Correction requirements are not maintained.
- Large user customers may qualify for a volume discount. MainPower will take into account a customer's load characteristics and other relevant circumstances.
- A Fixed Network Charge waiver may apply for certain supplies in special circumstances, i.e. when approved by MainPower in writing.
